



## ***24 Hour Access Rules & Regulations***

A 24-Hour Access upgrade is a special membership based on trust and is a privilege, which can be taken away immediately by Doyle Community Center Management for a violation of rules. As a 24-Hour Access member, you agree to abide by all gym and membership rules. Failure to comply could result in warnings, fines, suspension and/or termination of your membership and possible civil infractions.

- a. A 24-Hour Access Membership is required to use the facility outside of regular operating hours.
- b. Only one 24-Hour Access member may enter the 24-Hour Access door at a time. Every member that enters after regular operating hours must register their entry by swiping their own personal 24-Hour Access Membership Card. During regular operating hours, all members must enter/exit through the main front doors.
- c. Card Sharing is strictly prohibited and will result in immediate membership suspension and/or termination without refund. Card sharing is viewed as stealing services and will be reported to the local police.
- d. Personal Training or any service or activity in which money is exchanged is prohibited. The facility may not be used for personal or private business.
- e. Members are expected to be responsible to help maintain the gym and premises. Members will be expected to clean up after themselves and put away their weights and clean equipment after each use.
- f. Loud, vulgar or profane music will not be tolerated. Members must be respectful of all other users while in the facility.
- g. Use of chalk or other substances that would leave residue behind is strictly prohibited.
- h. Members are required to wear appropriate attire at all times while in the facility. This includes gym shorts, t-shirts, jogging suits, aerobic wear, sweat outfits and proper athletic footwear. Street clothing and jeans are not considered appropriate gym attire. Street shoes, work boots and black-soled shoes are also prohibited within the facility.
- i. Drugs (including steroids), alcohol and tobacco (smoking & chewing) usage is strictly prohibited in the facility. Members also agree to not use the facility or engage in any activity while under the influence of drugs, alcohol or medication that may impair their ability to operate the equipment.
- j. No photography, videotaping, filming or audio recording is permitted within the facility without the express written consent of Doyle Community Center Management.
- k. Food and gum is prohibited in the weight room. Beverages are permitted in sealable containers (no glass).
- l. Gambling or gaming is prohibited within the facility or on the premises.
- m. Under no circumstances shall a member move exercise equipment or use the equipment in any manner not authorized by Doyle Community Center Management.
- n. The climate of the facility is controlled by Doyle Community Center Management and is set to provide the optimum exercise environment for the majority of its members. Members shall not change or seek to change any environmental controls and shall never prop open any doors or windows for any purpose.
- o. Improper or unauthorized use of the facility may result in membership suspension or termination. Members agree to not allow anyone to use their card for any reason and agree to report any situation that appears to be card sharing to Management of the facility. One act of card sharing will result in immediate membership suspension and/or termination without refund.
- p. The Doyle Community Center reserves the right to suspend or cancel the rights, privileges and membership of any member whose actions are detrimental to the use, safety and enjoyment of the facility.

**NO SUPERVISION:** Please understand that by purchasing a 24-Hour Access Membership upgrade that allows access to the Iron Mill Weight Room at any time outside of regular operating hours that there will be no supervision or assistance except during regular operating hours. Be aware that if you get injured, become unconscious, suffer a stroke or heart attack or any medical emergency or event that there will likely be no one to respond to your emergency and that the Doyle Community Center has no duty to provide assistance to you while in the weight room. Understand that even though it is equipped with video surveillance cameras, help or assistance will not be available during non-staffed hours.
